Dear Acting Administrator Ward,


As part of President Obama's calls for greater oversight and reducing government waste, I have reached out to my constituents and encouraged them to contact me with instances where they feel that the government is spending wastefully or where funds are being improperly spent. Through this Waste Watchdog program, I've heard from a number of Iowans with concerns over government waste, fraud and abuse.

Recently, I received a complaint from an Iowa resident over the use of non-local contractors by FEMA for clean up and rebuilding efforts in Iowa following the flooding. I share their concern that FEMA is contracting work that could be done by local businesses, which would then further stimulate the economies of these flood-ravaged communities. While I understand that FEMA contracting regulations accept bids for projects and usually assign contracts to the lowest bidder, I believe that areas devastated by natural disasters could benefit from contracts going to local contractors who are able to complete the work. These contracts would have the added benefit of providing an economic stimulus and morale boost to companies and citizens that have already been hit hard by the disaster.

I would like to know what steps FEMA takes when entering an area affected by a natural disaster to ensure that local businesses capable of performing necessary services for FEMA receive the contracts for these services. Additionally, were these types of efforts made in response to the Iowa tornado and flooding disasters of 2008? If rules favoring local businesses in a disaster area are not in place, I strongly urge you to consider implementing these regulations that would support the local communities you assist in their time of greatest need.
